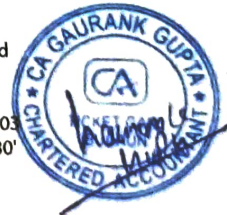

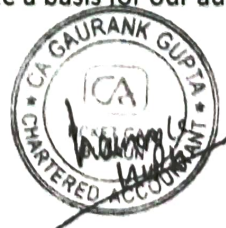
Management's Responsibility for the Financial Statements

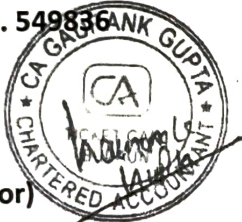
